Terms of Use

1. General Provisions

- 1.1. The company Blockchain investment group ltd accepts funds for management only on those conditions that are indicated by its marketing, presented on the official website of Binvest. There can be no individual conditions for individual participants.
- 1.2. All investors wishing to cooperate with the project must register on the official website, since it is impossible to perform financial transactions without a personal account.
- 1.3. The investment resource of the Blockchain investment group ltd Company, located at www.Binvest.ltd, is its full property; any copying of materials will be prosecuted.
- 1.4. The provisions of this agreement can be changed by the company unilaterally at any time. In the event of such changes, they take effect immediately after publication.

2. Rights and obligations of the company

- 2.1. The company reserves the right to amend the provisions of this agreement and not notify the project participants personally.
- 2.2. The company reserves the right to make changes to the current investment proposal, about which it undertakes to notify the project participants in the news section and by mailing to the postal addresses indicated during registration.
- 2.3. The company undertakes to pay the percentage of profitability indicated by the tariffs and fulfill its obligations to withdraw funds to the participants' electronic wallets.
- 2.4. The company reserves the right to block accounts and refuse service to participants who are noticed in defamation of Binvest and will deliberately denigrate the name of the company or its solvency.
- 2.5. The Binvest administration opposes spam, therefore it strongly recommends users not to resort to this method of disseminating information about the project. Appropriate measures will be taken against users who are found to be sending spam.
- 2.6. Binvest undertakes to ensure the technical health of the investment resource, to provide a secure connection for data transmission, to take all measures to protect the resource from DDoS and hacker attacks.
- 2.7. The company is not responsible for the lost profit by the participants due to a failure of a technical device or in case of malfunctions of the Internet provider.
- 2.8. The administration of the project undertakes not to transfer information about the participants of the investment project to third parties, except as otherwise provided by law.
- 2.9. The project is not responsible for the loss by the user of data to log into his account and the falling of this valuable information into the hands of third parties through the fault of the user himself.

- 2.10. The investments received from users will be used by the company in the framework of its activities. At the same time, users are not provided with a detailed report on the company's financial affairs.
- 2.11. The company does not accept claims or suggestions for additions or changes to the provisions of this user agreement.

3. Rights and obligations of the user

- 3.1. The user understands that this agreement can be changed at any time, therefore, assumes responsibility to timely familiarize himself with the information provided in this section.
- 3.2. Each investor who wishes to cooperate with the project must register on its official website, providing the necessary information about himself.
- 3.3. By registering on the Binvest website, the participant confirms that he has reached the age of majority and is eligible to perform investment activities.
- 3.4. The user undertakes to provide only reliable information about himself during the registration process. In case of changing any data, he is obliged to notify the administration of the project.
- 3.5. Any of the users of the project can fully use the investment offer from the company, as well as become a member of the affiliate program.
- 3.6. The user understands that the withdrawal of the received profit is possible only to the wallet from which the replenishment was made.
- 3.7. The project participant understands that he has no right to create more than one account for cooperation with Binvest.
- 3.8. The user may not have a personal deposit in the project and at the same time will receive profit from the affiliate program.
- 3.9. For any questions or problems that arise, the user has the right to contact the Binvest technical support service.

4. Final provisions

- 4.1. The parties are not responsible for failure to fulfill any of their obligations for reasons beyond their control. These reasons include the global or local economic crisis, military operations, terrorist acts, natural disasters and other events of force majeure.
- 4.2. The User Agreement (Rules) has the same legal force as the information provided on the website of the investment project.
- 4.3. Violation of the provisions of this agreement may result in the unilateral termination of the contract by the company. In this case, the user will be notified of such a decision by the administration.
- 4.4. This agreement is concluded for an indefinite period and will be automatically terminated.
